President Sgro opened the Public Hearing on the subject of our grant proposal for the PARC Grant to replace the Nelson Center roof and asked if anybody would like to address the Board Regarding this grant proposal.

Public Hearing

Jacki Patterson stated I'm here on behalf of the Springfield Hockey Association. So, I just have a statement that was prepared for me to read (Attached and made part of the application):

The SYHA has been under the Springfield Park Districts Nelson Center roof since 1970, over 50 years! The SYHA and the Park District runs programs from learn to play hockey to 18u hockey throughout the year. In a course of a year, approximately 260 players take the ice between the LTP, ADM, House and Travel programs.

During the course of a 22-week hockey season, just for SYHA partnership programs using both rinks, buy over 352 hours of ice plus another 96 hours for tournaments. To put that in perspective, over a 22-week period at 448 hours that roughly 20 hours a week (not including LTP) just for hockey development. That may not seem like a lot, but you have to remember that 20 hours a week for the roughly 170 players is a huge deal! During tournament weekends such as Presidents Day or the Capital City Freeze, the nelson center hosts roughly 1600-2000 people.

The Nelson Center is the only hockey rink within approx. 60 miles of Springfield. Having a functional ice rink for the central Illinois region is vital to the development of youth hockey players driving to St louis or Bloomington 3-4 times a week gets old really fast.

This Grant for a new roof would ensure a long-lasting footprint of hockey in this community. The SYHA isn't just about hockey, last year we started a community outreach program. Each team participated in an activity to help around the community, such as an Angel Tree, food drives, working with the Salvation Army and even volunteering at a local Food Kitchen.

As we all know, roof repairs and replacements can be very costly. The Nelson Center is where central Illinois Hockey players call home. With this grant funding, the Springfield Park District would be able to put the money they would be spending on a full roof replacement, back into much needed player development for members of this community. The SYHA continues to look forward to what the future brings in partnership with the Springfield Park District.

Trustee Theilen states on top of hockey we've also got figure skating and am I right that as she said we are the only rinks for the high school hockey?

Executive Director Harms states yes.

Trustee Theilen states so everything is in those two rinks.

President Sgro state yes, and not to mention the Junior Blues Hockey Team.

Executive Director Derek Harms states I've got a little presentation to present to the Board for purposes of grant application. (Also, attached and made part of the application)

Executive Harms states we're here tonight to present the project to the public and then solicit any feedback that we have before we submit the grant application. Here's an overview of the grant planning process. We've held several internal meetings, planning meetings and preparatory meetings with the board, with staff, with some consultants. We've met with contractors to get some guidance on the best way to move forward with this project tonight of course, the public input meeting and then after tonight we need to button everything up and submit the grant by Thursday of next week. So there's a lot of work that needs to happen between now and then which we will have done in time.

Executive Director Harms presents an overview of the outside of the existing area. (a copy which is attached as part of the application) On the left side of the screen you can see the outdoor pool that would be to the west. The bottom is the parking lot. On the right-hand side, you can kind of see the part of the Nelson Center and the White Building and then this is an old picture, but it looks like tennis courts, but is now deck hockey and of course in the center is the Nelson Center. One on the left side looks like the shingle roof and the one on the right-hand side is the new addition, the 20-year-old new addition.

Executive Director Harms states as Jacki indicated this is an extremely busy facility, probably our most heavily trafficked facility that provides services that we provide to the community. It includes 2 ice rinks and a twenty-two hundred seat multi-purpose Ice arena and facility. Beyond youth hockey as trustee, Theilen indicated, we also have figure skating, public skate in there, high school hockey. It's also home to the Springfield Junior Blues, which is an NHL hockey team, and the Nelson Center also provides multi-purpose space for recreation programs, instructional classes, day camps, inclusion programs, special events and provides rental opportunities for both public and private community gatherings. This is a very active site. The project that we are proposing is to replace the roof, the section that's red in color. We must replace that section of the roof. Under this roof it includes rink 1 and includes Franklin Room, six locker rooms, mechanical rooms administrative offices, the main lobby concession stands the kitchen off the Franklin Room and several restrooms. It's really the backbone of the operation of the Nelson Center. The roof is currently roughly 35 years old. It's been very well maintained, but it is certainly showing its age. It has bubbles in it. The granules that are on the roof in some spots are completely gone. It has had leaks over the years, and we have repaired and patched it many many times, but it desperately needs to be replaced. It is outside its useful life. So, the project that we're proposing is the roof as well as gutters and downspouts. And I think there's maybe some wood that needs to be replaced as part of the project too, that will all be wrapped up in this grant application. The new roof will have a 30-year warranty on it for a total project cost of an anticipated 1.2 million dollars so that will be our grant application. Since we last spoke to the board, IDNR hadn't announced whether Springfield was going to be categorized as a distressed community or not. If we are not a distressed community, they cover 75 % of funding, and we are responsible for 25 %. If we are a distressed community, they cover 90% and we're on the hook for 10%. They have released a list of distressed communities and Springfield is in, which list is bittersweet. But for the purpose of the grant, they'll fund 90% if we are awarded it. So, it would be a \$1.2 million grant application and we would be responsible for \$120,000 of that at this point.

President Sgro states that it is an amazing deal.

Executive Director Harms informs the Board that we're in the process of writing the grant, so we wanted to see if the public had any thoughts or ideas, and we appreciate Jackie sharing from the Springfield Youth Hockey Association the value that the Nelson Center has.

President Sgro asks the board if they have any further questions and said let's go for it. We know we need to do it.

Director of Parks and Planning, Jason Graham states we applied for this back in 2021 and didn't get it. We did all the preliminary work already, so we have some things done for this already and we went up there and checked.

President Sgro asks if they know why or any indication of something or a reason why we couldn't get it in 2021, that might make us more eligible this time.

Executive Director Harms states we don't get any report back from IDNR.

President Sgro states I just wondered. If there was a lesson learned, or you know.

Executive Director Harms states that question was posed to the director of IDR at the legislative conference here a couple of weeks ago, but we don't know.

President Sgro states, OK, very good and go get them.
