# **MINUTES**

Roll Call

President Sgro called the meeting to order.

#### **Committee of the Whole**

#### I. Long Range Planning

1. Reappropriation of funds to purchase boom truck.

Jason Graham, Director of Parks and Planning, reminded the Board that it approved \$200,000 in the 2022 S&I Bond Fund, Acct # 35-01-5350 Project Code 35-010010 for the purchase of a Boom Truck for the Natural Resources Department, but Reappropriation is needed from the 2016 S&I Bond Fund, Acct # 32-01-6278 Contingency for Market Pricing Adjustments w/ a balance of \$25,721.93 in the amount of \$14,600.00 to complete the purchase due to the price increase.

- 2. Kiwanis Park Development
  - a. Park shelter/bathroom

Jason Graham, Director of Parks and Planning, requests authorization from the Board to utilize the District's cooperative purchasing agreement with HGACBuy to purchase the Kiwanis Park OSLAD Re-development Park shelter and bathroom for an amount not to exceed \$140,000.00

b. Bid Results - Asphalt and field grading.

Jason Graham, Director of Parks and Planning, PROVIDED THE Board with bid results for the development of Kiwanis Park and requests authorization for staff to negotiate and execute a contract with low bidder Ron Furman's Commercial Sweeping and Paving in the amount not to exceed \$295,150.00 for the Kiwanis Park OSLAD Re-development bid package for asphalt and soccer field grading.

3. Erin's Pavilion Heat pump repairs

Jason Graham, Director of Parks and Planning, stated to the Board that in regard to the Water Furnace Heat Pump, the technician identified the unit tripped off on low pressure alarm upon arrival. After further diagnosis, a non-repairable leak was identified on the lower corner of the evaporator coil, and the unit was flat on refrigerant charge. We previously did these repairs back in December of 2022 on a similar unit, but the price has increased since then.
